#### **Sermon Topic and Scripture**

"Something Greater" Matthew 12:38-50

#### Discipleship

Proposed Changes to the Constitution & By-Laws:

The Constitution and By-Laws committee has recommended some changes to our Constitution and By-Laws. These changes were approved by the deacons and presented to the church at the business conference on August 13. The church will vote on approval at the next business conference on September 10. The proposed changes focus on simplifying our committee and organizational structure.

Everything we do should be guided by the Bible. Considering changes to our Constitution and By-Laws should begin by considering the biblical basis for having one in the first place. While the Bible says nothing specific about how it should be organized, there is general support for having one. First, it is a requirement of the state for every organization. Therefore, one reason we should have them is to submit to governing authorities (Romans 13:1). In addition, the New Testament instructs churches to do everything "in a fitting and orderly way" (1Corinthians 14:40). The Constitution and By-Laws helps us achieve the instruction of this verse by putting into writing what the different roles are for leaders and what process is for making decisions.

However, these rules are not meant to be set in stone. It is simply a document meant to help our church be efficient in making decisions and managing our resources in a way that honors God. Multiple discussions among leaders in the last few years have brought attention to frustration with maintaining everything that the Constitution & By-Laws calls on the church to do. Rather than working harder at maintaining the By-Laws, it is my opinion that it would be better to simplify and rework them in a way that better serves us. The deacons and Constitution and By-Laws worked hard to make changes that streamline some of the organizational structure and decision making process. For instance, the Personnel Committee and the Stewardship Committee would be combined into a single committee. I encourage you to look at the proposed changes and

ask any questions that you have ahead of next month's Meeting.
